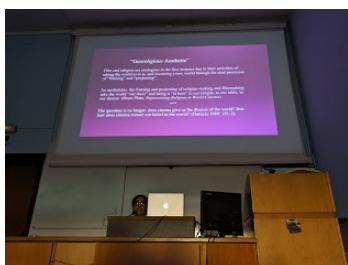
• WHAT IS THE SUMMER SCHOOL IN RELIGIONS AND PEACEFUL COEXISTENCE?

The Summer school in Religions and Peaceful Coexistence is part of the teaching activities of the “King Hamad” Chair for interreligious dialogue and peaceful coexistence, established at Sapienza University in 2018. The Summer School intensive programme revolves around the historical, cultural, and social dynamics of religions, understood in a perspective of dialogue and peacebuilding and with a cross-historical approach. Its main aim is to provide analytical instruments, methods, and skills in order to critically study the interactions between religions from the point of view of peaceful coexistence. Taking advantage of the rich history and culture of Rome, our Summer School enables our students to take part in a variety of activities ranging from specific academic lectures to interactive workshops and field trips to relevant spots of the Eternal City.



• LECTURES

40% of our Summer School is based on lectures held by well-respected scholars and researchers, both from Sapienza University and international institutions. Our lecturers put their expertise at the service of the students, enriching their Summer School experience with a solid academic content, in an interdisciplinary, cross-cultural and cross-historical perspective.



• EXPERIENTIAL LEARNING AND FIELD TRIPS

60% of our Summer School activities is interactive and experiential. Our students are trained to develop critical and analytical skills, and they are constantly stimulated to be active part in the learning process. In order to achieve what we believe to be one of the main goals of a proper academic education – namely active involvement and critical thinking – we organise workshops and walking tours across the city. Our students are encouraged to learn how to manage teamwork and group discussions, and how to read both the cultural heritage and the current “religionscape” of the surrounding environment. The Interactive workshops revolve around themes such as tolerance, hate speech, superdiversity, and others, while our Ateliers of research enable our students to glance at the current trends of religion-related academic research. Besides such classroom activities, our walking tours aim to show the layered and multifaceted presence of religions in Rome, with visits to Christian, Islamic and Jewish landmarks.

• PROGRAMME FORMAT, MODULES, CREDIT AND ASSESSMENT

The training activity consists in 24 hours of lectures and 36 hours of workshops and academic related walking tours, amounting to 60 hours of total commitment. At the end of the Summer School each student obtains a certificate of attendance and 8 ECTS, provided that they have completed the whole programme and submitted a brief final essay.

• ENTRY REQUIREMENTS

To be eligible you must be enrolled at a university. Knowledge of English is a must.

The cost of the Summer School is €650. This fee includes:

The cost of flights, airport transfers, health insurance and accommodation is not included. Depending on availability, study grants might be awarded to deserving applicants.

Art. 1 – Application for admission

To enroll in the Summer School, candidates must:

1 - Students not enrolled in Sapienza:

Register on Infostud by accessing the University's website
<https://www.uniroma1.it/it/pagina-strutturale/studenti>

Once your registration is completed, the system will provide you with a registration number and a password to access the system. You must use this registration number on your Application Form (Attachment 1).

2 - Students currently or previously enrolled in Sapienza:

There is no need to register as you already have a serial number and password to access the Infostud system. In case of loss, you can retrieve your service number and password using the automatic procedure of the Infostud system.

ATTENTION: it is important to insert a valid e-mail address, because the password recovery procedure takes place via e-mail.

It is also necessary to keep, once obtained, the serial number and password, because they will be needed for free Internet access via the wifi connection of La Sapienza during the Summer School.

3 – Complete the application for admission to the Summer School, in plain paper, using the form attached to this announcement (**Attachment 1**).

With the application form the following documents **must** be enclosed:

- Photocopy of a valid identity document, duly signed and readable
- (Identity Card/Car License/Passport);

- Self-certification of Secondary School or University degree obtained and eventual certificate of enrollment to University;
- Signature of the Declaration of consent for the processing of personal data (Attachment 2);
- Updated CV with Photo;
- Letter of self presentation/motivation (one or two pages), indicating the course of study undertaken, interests, motivations for participation in the Summer School.

The application for admission (signed by the applicant and scanned in PDF, JPG or PNG format), accompanied by all attachments (also scanned in PDF, JPG or PNG format), must be received no later than **1 April 2020** only by sending it to the following e-mail address: chair.kh@uniroma1.it

In order to apply for a possible scholarship, the application must be received by **1 March 2020**.

Art. 2 - Ranking of the admitted participants

The course secretariat will check the admission requirements and publish a list of participants of the Summer School course by **10 April 2020**. **NEW!! 18 JULY 2020**

Following the publication of the ranking list, it is possible to register for the course via the Infostud system and pay the registration fee.

Art. 3 – Registration fee for the Summer School course

Participation in the course includes an amount of **€ 650** plus the stamp duty of € 16.00 paid virtually, to be paid according to the modalities of the articles 5 e 6 **no later than 2 May 2020**.

Students with a recognized disability equal to or higher than 66% or with a recognized handicap according to art. 3, paragraph 1 and 3, of the law of 5th February 1992, n. 104 **are exempt from 50% of the registration fee**.

Students coming from La Sapienza, or from Universities with which La Sapienza has agreements, will have a **20% reduction of the registration fee**.

The registration fee can be refunded only and exclusively if the course is not activated. In this case, the student must submit an application to the Course Director to obtain the refund.

Art. 4 – Duration and organization of training activities

The Summer School lasts six days. The lessons will start on **15 June** and they will end on **20 June**.

NEW!! 31 AUGUST - 5 SEPTEMBER 2020

The training activity is equal to **60 hours** of total commitment, of which 24 dedicated to frontal teaching activity.

The entire participation to the Summer School will give an attendance certificate and the acquisition of **8 ECTS**, according to the rules in degree courses of 1st level, provided it is consistent with the contents of the course itself

In case of non-attendance, or other censurable behavior, the Director may decide not to issue the certificate of attendance of the Course. In this case the registration fee paid will not be reimbursed.

Art. 5 – Method of payment of the registration fee for the Advanced Training Course

Students admitted to the course must login to Infostud2.0 from <https://www.uniroma1.it/it/pagina-strutturale/studenti> , with registration number and password, click on the box “CORSI DI

FORMAZIONE", then click on "TASSE - Immatricolazione", enter the code of the Course indicated on the announcement and follow the instructions below.

The payment of the enrolment fee must be made within the deadline provided for in this announcement (see point 3), through the payment form ("bollettino") downloaded from Infostud according to the methods illustrated on the web page of the Sapienza institutional website: <https://www.uniroma1.it/it/pagina/come-pagare> or through the PagoPA payment service.

Professors of educational institutions of all levels can pay up to € 500.00 through the use of the so-called "**Carta del Docente**".

In this case, after the deadline indicated in art. 3, the participant admitted to the Summer School must write to the e-mail address altaformazione@uniroma1.it attaching the bonus generated by the MIUR website to receive, again by e-mail, a bulletin to pay the difference, if due, between the course registration fee and the amount of the bonus.

Art. 6 – Methods for payment of the registration fees for the course by an organization / company

To finance the enrollment of a person or more people to a course it is necessary that the beneficiaries of the funding register on Infostud and obtain the bulletin as described in point 7, and then they follow the following steps:

1 - the financing company must make a transfer equal to the amount indicated in the bulletin downloaded by the beneficiary on the following IBAN: IBAN Code: IT71 I 02008 05227 000400014148 Code of Entity: 9011778 Unicredit University Treasury - Agency 30660 In the reason it is necessary to indicate: "FORM (course code) matr. (Student matriculation)". For those who make transfers from Unicredit agencies it is also necessary to indicate the account number Ateneo 1001

This indication is essential to match the payment to the beneficiary in the course. If there are multiple beneficiaries, change the total amount of the transfer and the reason for payment with the details of all the beneficiaries.

●Consent to the use of personal data in accordance with the D.Lgs 196/2003

●Purposes of the processing

In accordance with the section 13 D.lgs. n.196/2003 the provided data will be processed in the necessary measure and for the purposes connected to the enrollment and the attendance of the training course.

●Methods of processing and subjects involved

The data will be both hand and computer processed. They may be communicated to institutions, public or private companies only if strictly necessary for the activities of the Summer School.

●Provision of data and consequences in case of refusal

The provision of data is mandatory; refusing to provide the necessary data will result in the impossibility of being admitted to the Summer School and participate in its activities.

●Holder and supervisor of the processing

The holder of the processing of the data is the Università degli Studi di Roma represented in person by its pro tempore legal representative, the Magnifico Rettore, domiciled for the role at Sapienza University of Rome, Piazzale Aldo Moro, 5 – 00185, Rome, Italy. The supervisors of the processing are the Directors of the Summer School.
